The government states that councils must prove that there is a minimum of a 5 year land supply for homes to be built on. If they can't prove this, developers can put in speculative plans and it is MUCH easier for them to get planning permission.

For a couple of years, this land supply was hanging in the balance at East Herts District Council. I think we were only a few months short, and as a result building companies were putting in plans to build large developments.

In January, it was confirmed by planning officers that the district has 5.7 years land supply and as a result it will be more difficult to build large estates in the area. This is welcome news for people who are concerned about the over development of our countryside.
